Privacy Policy Statement for Guangdong Daya Bay Nuclear Power Station Visit**

HKNIC requires the supply of your personal information to facilitate your application and organise your visit to the Guangdong Daya Bay Nuclear Power Station (“**Daya Bay**”). To better protect your privacy, we provide this notice explaining our practices and the use of your information collected by HKNIC.

The personal data that we collected

HKNIC requires the following information: your name in Chinese and English, gender, occupation, date of birth, HK Identity Card Number, details of your valid PRC Re-entry Permit or passport. We shall need the information two weeks in advance of your visit.

Please note that you are not required by law to provide the information but HKNIC may not be able to arrange the visit to Daya Bay if the information is not complete or provided on time.

How we use the personal data

We shall use the information for your travel arrangement, for meeting the operational, security and entry requirements of the PRC business entity responsible for Daya Bay and for meeting PRC law enforcement requirements.

The information will be used solely for the above purposes. We shall erase, or procure that any third parties to erase, your personal information when it is no longer required for the visit.

Transfer of Personal Data

For the above purposes, we shall make available your personal data to our designated travel agent for your visit, and to the PRC business entity responsible for Daya Bay. We shall not transfer your personal data to any third parties other than those indicated above unless such transfer is required for facilitating your visit to Daya Bay.

Enquiries

You are entitled to be informed and to correct any information that we keep of you. To access and correct any of your information, please address your request in writing to HKNIC, 8 Laguna Verde Avenue, Hung Hom, Kowloon, Hong Kong. We may make a reasonable charge for complying with such a request.
